BOARD ADOPTS STRONGER ATTENDANCE POLICY

Reviewing the average attendance figures ranging from 72% last January followed by 62.7% in February down to 47% in May, the new Board of Directors last Tuesday noon agreed to clamp down on non-attenders.

While By-law provisions are specific with regard to suspension for non-attendance, previous Boards have been a bit lax in applying the rules.

It is the feeling of this year's Board that any Kiwanian unable to attend - or make up attendance for - the 40% minimum or averaging about every other meeting during the year, should be suspended.

So, fair warning has been issued. Remember, however, that participation is one of your greater assets in being a Kiwanian - and participation gets its greatest boost from attending our weekly meetings.
