### '67 OFFICERS INSTALLED LAST WEEK

Lt. Governor L. B. DeWees officiated at his first installation of officers last Wednesday noon - and we'd like to think that this might just set a precedent for our Cedar Rapids club to reach a few more firsts in the division during the new year.

Gaining official status for 1967 were: President - Frank Cosgrove; First Vice President - Warren Kintzinger; Second Vice President - W. Howard Smith; Treasurer - Ken Holvenstot; and Past President - Jim Bowker.

### SECRETARY EMERITUS CONFERRED

In special ceremony conducted by past Governor Don Isett, a special citation was awarded long time Secretary Tony Pleune. Tony was elevated to Secretary Emeritus of the Cedar Rapids Kiwanis Club.

Included in the citation, Isett mentioned that Tony joined our club in 1921 with 34 of that 45 year span in perfect attendance - an unequalled record in most clubs. He has served as our secretary for 15 years, and has chaired the Youth Welfare committee for a longer period. He has been the prime mover in our Gumball machine project which has provided over \$33,000.00 in youth services such as dental and eye care work for deprived children.

A standing ovation for Tony followed Isett's remarks as a grateful Kiwanis Club honored one of its finest members.

Tony will continue to serve as acting secretary pending Board action to name a successor.
