## CONSERVATION REVIEW HEARD LAST WEEK

George Hamilton, Director of the Linn County Conservation Board, spoke last week about the conservation program currently being implemented here in Linn County. (And Doc Fenner wasn't even in on this one!)

Hamilton showed several slides of projects in the county - visual proof that we have one of the finest conservation and recreation programs in Iowa.

Special guests included Mr. Fred Poyneer, long active in state and county-wide conservation programs; Mr. Doyle Adams, a member of the State Conservation Commission; both were presented by our program vice president, Howard Smith.

Dan Schwitters introduced his guests: Virgil Peters, an associate; Supervisor Chairman Dudley Henderson (Kiwanian at Central City); Supervisor George Michel; and County Conservation Commission member Bill Cooper.

The professional vs. union question among teachers of the nation had definite overtones in Cedar Rapids and it may well become of increasing pertinence in our public school system.

Next Wednesday noon, December 6th, we'll have the opportunity of hearing about the problem from Mr. Robert Arnold, President of the Cedar Rapids Education Association.

A product of Cedar Rapids schools, Bob is currently a classroom teacher at Erskine, and holds an MA degree from SUI. He is also an officer of the Urban President's Council, an ISEA affiliate including the professional associations in Iowa's major cities.

The news this fall was full of what can happen in a community when teachers strike. Can it happen here? What is the so called "Blackboard Power" struggle?

Join us next Wednesday noon for answers to these and other questions which will certainly have at least some affect on our youngsters in school.
