BY-LAW CHANGES TO BE VOTED APRIL 17th

In accordance with notice provisions of our By-laws, the membership is hereby notified that a vote will be taken at the regular Wednesday noon meeting, April 17, on the following proposed By-law changes as approved and recommended by the Board of Directors:

ARTICLE III, Section 5 (b), deleting the second sentence and substituting: "A senior member shall pay annual membership dues of \$15.00 per year and shall be entitled to all privileges of this club."

ARTICLE XV, Section 2, deleting the sentence contained therein regarding dues and substituting: "The annual dues shall be \$42.00, payable quarterly, January, April, July and October."

The effect of the above will be to provide a lower dues for senior members, and raise the regular dues from \$36.00 to \$42.00 - at the same time reducing the requested contribution to the Marshall fund from \$12.00 to \$6.00 per year (net cost remains the same.) A 2/3 vote of members present is required for passage.

C.C. Birr, world traveler, Rotarian, and father of Secretary Bob Birr, will bring us a slide presentation of his latest junket to East Africa, next Wednesday noon, April 3rd.

He made the trip last fall, and as recalled from his visit with us last summer on his trip to South America, he shows many of the things the average traveler would like to see in making a similar trip (and that's his business).
