### December 26, Program

Howard Smith introduced our guest speaker, Dr. Peter Harstead, of the Iowa State Historical Society. Dr. Harstead discussed the various periods of history in Iowa's past including the pre-written times, the times of the explorers, the pioneer and settler periods and the more recent historical period from the time that Iowa became a state to the present. Dr. Harstead's main theme was that from the earliest days of Iowa, the active members of her communities were always interested in Iowa's history. This is in direct contradiction of O. Spengler's philosophical theorem which stated that a country had reached it's "autumn period" when it became deeply involved with it's past.

The current proposed projects and the monetary needs of this state supported organization were also outlined by Dr. Harstead.

These tickets, when purchased for \$15, entitle the purchaser to free meals and services at various local establishments.
