Roosevelt Hotel---Dr. Dale D. Morgan, M.D. discussing a subject the press has labeled "The Right to Die." Dr. Morgan has practiced Anesthesiology in Cedar Rapids for 17 years. He was graduated from Franklin High School, Cedar Rapids; received his B.A. Degree from Coe College and then went on to study medicine at the University of Iowa. Dr. Dale is married and has two daughters, ages 16 and 18 years. He was a medical officer in the Navy during the Korean War and in the fall of 1966 served aboard the volunteer-manned medical ship U.S.S. Hope.
