It isn't that I don't want to give you coverage, but somehow I run out of time to hold down a job, cover the beat, locate you, and ask the right questions!

LAST WEEK

Our friend and former fellow DOWNTOWN KIWANIAN Bob Birr discussed the problem which results from the mixing of automobiles and alcohol, and what Iowa is doing to try to reduce the number of accidents which result from that explosive mixture. The program is one which forces the person who has been arrested for driving while "under the influence"---, has been convicted and has had his license revoked to attend a four-week course which is designed to show him the error of his ways and potential danger to himself and others. There were 2633 such cases last year and 1001 during the first three months of this year! We have a problem.

The course, which was implemented the first of March, 1973, is taught by the community colleges. Staff members of agencies concerned with the counseling and treatment of problem drinkers sit-in to try to identify individuals they feel they can help. When a driver has been arrested and tests show he is under the influence of liquor, he is convicted, his driver's license is revoked. He is then assigned to a "class", given a limited driving permit to allow him to drive to his place of employment and, in effect, is ordered to attend the course. When he has satisfactorily completed the course, he is given an opportunity to take the standard driver's test again and start over with a new driver's license. Of course there are a lot of side effects. The "student" has to arrange for special (high priced) insurance following conviction. Must pay 20 bucks to take the course. Pay a fine of several hundred dollars. The way Bob Birr had it figured---the person so involved could wind up stuck with a bill of \$1,340 over and above what he would have paid if he hadn't gotten into the mess. Pretty high priced cocktail! But, hopefully such treatment will convince the majority of the offenders that drinkin' and drivin' shouldn't be mixed.

SHOES NOT BOOZE

But one shouldn't jump to conclusions---According to an AP story in the Gazette, June 6, 1973, Arthur Perry (no relative) admitted to a judge in Memphis that he was "kind of weaving" when he walked down the street. But he said it was his new high heeled shoes and the rocks in the road! The judge dismissed the case.
