But seriously---Duane Anton lined up an excellent program to fill in. George Hamilton, Director of the Linn County Conservation Commission took us on a slide tour of the county parks. As an old park trumper, I can vouch for the authenticity of Mr. Hamilton's statement that Linn County has some of the finest parks in the state. Have often thought---wouldn't it be nice if familiarity and knowledge of our own city, county, state and nation rated with "travel abroad" as a status symbol? I know, sour grapes!

IOWA OUTDOORS

Per George Hamilton-----93 of Iowa's 99 counties have County Conservation Commissions; the Legislature passed the bill creating this system in 1955; Linn County's commission was organized in 1959 and began operation in 1960; Linn County has 5,000 acres of park land with nearly a million visitors per year. Financing capital expenditures, operation and maintenance comes from property taxes, user's fees (camping and picnic facilities) and Federal funds. (The latter unpredictable in both amount and timing.) Approximately one half of the 5,000 acres is open to hunting; much of the park land is along streams and is flood plain land; camping clubs are a bit of a headache to the conservation officers, as the number of vehicles per family is beyond imagination-----several cars, a trailer or motor home, a boat and possibly several two-wheeled vehicles per family! (There are 30 "recreation vehicles" licensed for every available camping stall in the U.S.!)

But, George Hamilton says they do their best to cope. However, he admits he does have one real problem. The "wild" Mallard ducks the Commission raises for release in the parks are so tame and dumb that they sometimes gather on the roads and hold up traffic! Wonder why a duck crosses the road?
